1. BUSINESS AGENDA – 1:00 pm

The meeting was called to order by Vice Chair Erick Lee at 1:04 p.m.

a. Roll Call

b. The Agenda for the March 3, 2016 Governance Board Meeting was posted on February 26, 2016 on the ICI System Web Site and the Bulletin Board outside Glendale City Hall.

3. REPORTS – INFORMATION

a. Reports Regarding Changes in Project Status from Previous Month

Beverly Hills – No report

Burbank –Jim Compton reported that Burbank's upgrade to P-25 has been finished and he expressed his appreciation to the Technical Committee staff's diligence and hard work on this project.

Com Net – Tim Staab imparted that Com-Net is still anxiously awaiting approval from FCC for their radio frequencies, which they hoped to have been accomplished by end of last year.

- Director Edey stated that they received a correspondence from one of FCC's chief technical analysts, requesting for two additional documents. He expressed that it is a good indication that Com-Net's application is being processed and just proceeding through the several phases before reaching the Public Safety Approval body.

Tim Staab also informed the panel that Com-Net is experiencing some technical issues involving a microwave they purchased 14 months ago. He said that the equipment has always been operational but the communication to Glendale is problematic; hence their initial assumption that the problem was the Glendale site. He reported that upon thorough inspection, it was found out that it is being caused by router incompatibility since they didn't purchase the equipment through Motorola, who created the Com-Net system that was only configured for T-1s and not microwaves. He said that they contracted Motorola to make the necessary adjustments.

Glendale – Absent Culver City – Absent

Montebello – Dan Amador reported that four out of five Montebello sites along the lines of Burbank have been completed with the P-25 migration upgrade.

b. Report from Technical Committee

Jim Floyd, Vice Chair of Technical Committee, reported what was discussed during their recent meeting. Status updates were: Beverly Hills was in the middle of their microwave upgrade; Burbank – 90% completion of P-25 reprogramming of their fleet; Culver City also in process of microwave transition they are working on with their subscriber units. Jim also shared with board members the content of a memorandum issued by Burbank City Manager to their City Council meeting in February, commending the successful completion of Burbank's P-25 conversion which was incredibly achieved under budget and on time.

c. Report from Operations Committee

Director Edey informed the board that Operations Committee is in a state of flux and seeking to reinvent itself with respect to its functions and to reinstate the Chair of the committee. He conveyed that Don Weise, who recently expressed his intent to step down from the position, gladly announced that he will be staying on and will continue on as Chair of the Operations Committee.

d. Grant Status Report

Director Edey presented to the panel the Grant Status Report as of March 3, 2016. Listed are active grants currently in place and those that are still pending which are as follows: 2014 SHSGP - funding Torrance and Montebello sites; 2014 LA/LB UASI - for Vernon, Glendale, and Santa Monica projects; 2015 SHSGP - for Com-Net, Montebello, and Glendale systems; 2016 LA/LB UASI Application - for Area G/Torrance/South Bay Cell, ISSI Interface, and Monterey Park Area Repeater, and lastly the 2016 SHSGP Application - to be reinvested for West SGV Reconfiguration. He, however, reminded the board that these numbers aren't absolute as these grants will continue to develop and redevelop each year and might change when some residual funds become available.

e. Report Regarding the I.C.I., LA-RICS, LAPD, and LB UASI Technical Committee

Director Edey stated that as he discussed during the previous board meeting, UASI's Approval Authority directed the formation of joint technical committee between ICI System, LA-RICS, Los Angeles, and Long Beach, to facilitate them in determining the feasibility of funding these four radio system entities. Director Edey informed the panel that the newly formed group already held several very productive meetings since then, and have already reported back to the Mayor's office that they are prepared to proceed with system integration.

Director Edey also informed the board that a joint Operations Committee was also formed within the group. He reported that they had good meetings but are still in the process of establishing the policy level and determining each entity's role. He conveyed that the committee met with the UASI Approval Authority, to brief them on the group's progress and what was discussed during the process.

f. Report on Status of Santa Monica System Cell

Director Edey was pleased to announce that because of the successes they had in 2014 and for being able to allocate a sufficient grant funding to Santa Monica, their City Council accepted that funding to move forward with the design, fabrication, and insulation of their ICI cell system; this will cover their prime site, two repeater sites and all their connectivity. He also stated that they got City Council approval to seek membership in the ICI System JPA, as well as funding for their annual membership dues.

g. Report on Status of Torrance/South Bay/Area G System Cell

Director Edey reported that the project is about ready to launch; they got the funding for the prime site and are just waiting for EHP clearance. He conveyed that they are moving forward onto the next UASI grant cycle, seeking sufficient funding to build out the entire Area G Cell. Out of the eight cities in Area G, he said that only one is not participating; Inglewood has opted thus far to continue working with LA-RICS. Director Edey stated that this project will comprise multiple communications centers and five additional regional radio sites on top of the prime site that is currently being worked on in Torrance. He further emphasized that this is a substantial cell and is the last link in the ICI System puzzle for the coverage of the entire county.

h. Report on Washington, D.C., Delegation for 2016
